

1) The total number of allegations/complaints made to Gsoc against gardai in Ireland this year, with a breakdown by Garda Division - with a brief description of the nature of each alleged breach of discipline.

The total of complaints received to date (mid-September 2020) was 1,182 complaints with 1,719 allegations contained within. Please note that one complaint can contain a number of allegations.

Note - All complaints received by GSOC are assessed against criteria listed in the Garda Síochána Act 2005 to determine if they are admissible. If they meet the criteria, they can be dealt with by GSOC; if not they are deemed inadmissible. (see list below)

According to section 87 of the Act, GSOC can admit a complaint if it:

- Is made by (or, in certain circumstances, on behalf of) a person who is directly affected by, or who witnesses, the conduct subject of complaint;
- Is about behaviour which would, if proven, constitute a criminal offence or a breach of Garda discipline by a member of the Garda Síochána;
- · Is made within the time limit of within one year of the incident subject of the complaint;
- Does not relate to the general direction and control of the Garda Síochána by the Garda Commissioner; and
- Does not relate to the conduct of a member of the Garda Síochána while the member was off duty, unless the conduct alleged would, if proven, be likely to bring discredit on the Garda Síochána

**Note** – Some complaints can have more than one unique outcome for example partly admissible. There can also be more than one allegation within the one complaint with different outcomes.



#### **Explanation of outcomes:**

- \*\* Further investigation not necessary or reasonably practicable –There was not enough evidence to substantiate either version of events so the complaint could not be proven or disproven.
- \*\*\*No breach of discipline regulations identified At conclusion of investigation the report received by GSOC indicated no breach of discipline.
- \*\*\*\* GSOC identifies no misbehaviour following criminal investigation The most common scenario here is that there was no independent evidence to prove the allegations made.
- 3) In the case where a finding/allegation has been upheld, the punishment/fine handed out.

Two breaches of discipline were identified to date (mid-September) in the 2020 complaints. One case resulted in a caution and the second was regulation 10 advice.

4) I would also like to request the number of allegations/complaints Gsoc has received this year against gardai in relation to Covid-19, or the enforcement of laws connected with Covid-19, and a breakdown by the nature of these complaints and a breakdown by Garda division.

As of the 11th September 2020 the number of complaints to GSOC in which Covid 19 was mentioned as a factor is 228 cases (in total).
